*ELECTIONS:

TREASURER – Andy nominated and accepted. Andy elected by acclimation.

<u>EQUIPMENT MANAGER</u> - Cody Hoy and Greg Bodnaryk nominated. Cody accepted and Greg did not accept nomination. Cody elected by acclimation.

<u>TRAINING OFFICER</u> – Greg Bodnaryk and Eric Brogno nominated. Greg accepted and Eric did not accept nomination. Greg elected by acclimation.

<u>SECRETARY</u>- Jackie Ohnander and Nigel Fisher nominated. Jackie accepted and Nigel did not accept nomination. Jackie elected by acclimation.

<u>INFORMATION OFFICER</u> – Kevin Weir and Zoe Walton nominated. Both accepted nomination. Kevin elected by majority vote.

*Signatories: Motion to keep Andy, Cody, Shauna and Jordon as signatories. Motion passed.

*Road Rescue: Kyle made a motion that as of GADSAR's lease expiry date at HMC (May 2012), GADSAR ceases responsibility for road rescue operations in our current capacity. Motion seconded and all in favor. Discussion: Some members want to stay involved in conjunction with the fire department, Town of Golden or possibly a road rescue society or similar model to offer our expertise and training. GADSAR

would need a significant amount of money and resources to continue to offer the services as we have in the past and as a sole provider. The reimbursement rates from the province do not cover the cost of operations. There are liability concerns with our response numbers (which are down) and times (which are up due to HMC location). Shauna + Kyle will draft a letter of GADSAR's Road Rescue intentions.

- *Recruitment drive/implementing intake interview process: the biggest concern at the moment is the retention of members. GADSAR will implement a short intake process of all new recruits. Shauna, Greg and Kevin will work on the intake interview process.
- ***2012 Training:** Members need lots of notice for multi day training to ensure time off from work. We will consider a mix of weekend/mid week training along with weekend courses this year.
- ***FUNDING Status:** CSRD Director has verbally guaranteed a commitment of \$22,000 for the next 3 years.
- *Website UPDATE: Cody working with software tech. Members can set up account and receive emails, training, call outs, gear usage etc. The old site will be closed down by ANDY and visitors will be redirected to new site. There will be a sponsor section in website for all donations. The new executive (and general membership) will have a training night with Cody for new website. Possibly in early March.
- ***EQUIPMENT UPDATES:** gear that's out of service is to be put on a certain shelf or in the other building after a call until it's checked and repacked.
- *PAGERS: Cody to send an email out to get 3 pagers back.
- *GAMING EXPENDITURES: flooring in upstairs of new buildings, furniture, router, another set of HETS gear,
- *GSAR: spreadsheet is updated, just needs to be sent in.
- *Task review for JAN 2012: 8 tasks in the month of which 4 were on the same day.
